Interim Management's Discussion & Analysis

* Quarterly Highlights *

This Management's Discussion & Analysis – Quarterly Highlights ("Quarterly Highlights") of Southstone Minerals Limited (the "Company" or "Southstone") is prepared as of July 21, 2023 and should be read in conjunction with the Company's unaudited condensed consolidated interim financial statements and related notes for the nine months ended May 31, 2023, as well as the audited financial statements for the year ended August 31, 2022.

The interim unaudited financial statements have been prepared by management in accordance with International Accounting Standards 34 'Interim Financial Reporting' using accounting policies consistent with the International Financial Reporting Standards issued by the International Accounting Standards Board and Interpretations of the International Financial Reporting Interpretations Committee.

All figures are in Canadian dollars unless otherwise stated. Additional information, including the above-mentioned financial statements are available on SEDAR and may be accessed at www.sedar.com.

Analysis of the Company's Financial Performance and Condition

The Company is reporting a net loss for the nine months ended May 31, 2023 of \$118,944, compared to a loss of \$391,615 for the comparative period ending May 31, 2022. The Company is reporting a loss for the three months ended May 31, 2023 of \$81,267, compared to a loss of \$209,934 for the comparative period in 2022. The biggest contributor for the lower loss in the three months ended May 31, 2023 is the increased revenues due to increased diamond sales. The biggest contributor for the higher gross profit related to the nine-month period was the increased revenues that occurred in the first and third quarter of 2023 due to increased diamond sales, as well as lower direct salary and wage expenses in the current period.

A comparison of the operational expenses from continuing operations are discussed below.

- The foreign exchange gains and losses fluctuation relates to the volatility of the South African Rand against the Canadian dollar for the period from September 2022 to May 2023.
- The management and consulting charges decreased compared to the comparative periods due to the lower fees paid to the former CEO and CFO in the comparative period.
- Office and general expenditures increased compared to the comparative periods due to relatively higher accounting costs.
- Professional fees decreased in the first nine months of fiscal 2023 compared to fiscal 2022 due to lower utilization of professional consultants. These services include, but are not limited to, legal, advisory and environmental.

Liquidity

Liquidity risk is the risk that the Company will not have sufficient cash resources to meet its financial obligations as they come due. The Company's liquidity and operating results may be adversely affected if the Company's access to the capital market is hindered, whether as a result of a downturn in stock market conditions generally or related to matters specific to the Company. The Company historically generates cash flow from both operations as well as financing activities. As at May 31, 2023, the Company had cash of \$16,387 to settle current liabilities of \$1,250,813. The Company intends to meet its financial commitments through loans, private placements, debt conversion, and profits generated from its operations. All of the Company's financial liabilities have contractual maturities of less than 365 days and are subject to normal trade terms.

The outbreak of COVID-19 has resulted in governments worldwide enacting emergency measures to combat the spread of the virus. Measures taken to contain the spread of the virus, including travel bans, quarantines, social distancing, and closures of non-essential services have triggered significant disruptions to businesses worldwide, resulting in an economic slowdown. The pandemic could continue to have a negative impact on the stock market, including trading prices of the Company's shares and its ability to raise new capital.

As at May 31, 2023, the Company has an accumulated deficit of \$22,113,266. The Company will require additional financing in order to further develop its business, meet its ongoing levels of corporate overhead and discharge its liabilities as they come due. While the Company has been successful in securing financings in the past, there is no assurance that it will be able to do so in the future. These factors indicate the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern. If the going concern assumption was not used, then the adjustments required to report the Company's assets and liabilities on a liquidation basis could be material to these consolidated financial statements.
